

particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, and Napoopoo Pier Site, being all of Land Court Application 1011, filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii, containing an area of 0.77 acre, covered by Owner's Certificate of Title 14,071 issued to the State of Hawaii, were set aside for the Kealakekua Bay Marine Life Conservation District, to be under the control and management of the Department of Land and Natural Resources, Division of Boating and Ocean Recreation; and

WHEREAS, the Board of Land and Natural Resources at its meeting held on October 26, 2012, approved the cancellation of Governor's Executive Order No. 3706 dated July 3, 1997.

NOW, THEREFORE, I, NEIL ABERCROMBIE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 3706 dated July 3, 1997, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.




