

for Kukuiula Breakwater Parts 1 and 2, to be under the control and management of the Board of Harbor Commissioners; and

WHEREAS, by Governor's Executive Order No. 2419 dated December 23, 1968, certain land and improvements situate at Kukuiula, Koloa, Kauai, Hawaii, containing an area of 6,000 square feet, more particularly delineated on the map marked Exhibit "B" attached hereto and made a part hereof, was set aside for Kukuiula Small Boat Harbor, to be under the control and management of the Department of Transportation, Division of Harbors; and

WHEREAS, by Governor's Executive Order No. 3114 dated January 14, 1982, certain land and improvements situate at Kukuiula, Koloa, Kauai, Hawaii, containing an area of 6.893 acres, more or less, more particularly delineated on the map marked Exhibit "C" attached hereto and made a part hereof, was set aside for Maritime and Maritime Related Purposes, to be under the control and management of the Department of Transportation, Harbors Division, State of Hawaii; and

WHEREAS, pursuant to Act 272, Session Laws of Hawaii 1991, the State of Hawaii, Department of Land and Natural Resources, is the agency responsible for the overseeing and administering the boating and coastal areas programs and therefore the above-referenced governor executive orders were transferred from the State of Hawaii, Department of Transportation to the State of Hawaii, Department of Land and Natural Resources by operation of law, effective July 1, 1992; and

WHEREAS, the Board of Land and Natural Resources at its meetings held on May 24, 2013 and October 25, 2013, approved the cancellations of Governor's Executive Order No. 1747 dated August 24, 1956, Governor's Executive Order No. 2419 dated December 23, 1968, and Governor's Executive Order No. 3114 dated January 14, 1982.

NOW, THEREFORE, I, NEIL ABERCROMBIE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 1747 dated August 24, 1956, Governor's Executive Order No. 2419 dated December 23, 1968, and Governor's Executive Order No. 3114 dated January 14, 1982, be and the same are hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.




