



Proclamation *Presented*

In Recognition of Fetal Alcohol Spectrum Disorders Awareness

WHEREAS, the **Hawai'i State Department of Health, Family Health Services Division** reminds us that "Fetal Alcohol Spectrum Disorders" is an umbrella term that describes the range of effects that can occur in a baby whose mother drank alcohol during pregnancy; and

WHEREAS, the **Hawai'i State Department of Health, Family Health Services Division** recognizes that prenatal exposure to alcohol can cause birth defects, intellectual disabilities, learning disabilities, attention deficits, and behavior disorders; and

WHEREAS, the **Hawai'i State Department of Health, Family Health Services Division** acknowledges that numerous studies show individuals with Fetal Alcohol Spectrum Disorder (FASD) often have numerous social disorders such as disrupted school experience, juvenile delinquency, homelessness, mental health and substance abuse issues, unemployment, and criminal behavior; FASD costs the United States an estimated \$5.4 billion annually in direct and indirect costs; and

WHEREAS, according to the Substance Abuse and Mental Health Services Administration (SAMHSA), 60 percent of women in the United States between the ages of 18 and 44 reported alcohol use in the past month; 33 percent reported binge drinking (four or more drinks in one sitting) in the same time period; approximately 10.6 percent of pregnant women in the United States reported alcohol use; and 3.7 percent of pregnant women engaged in binge drinking; and

WHEREAS, the **Hawai'i State Department of Health, Family Health Services Division** reminds us that the effects of FASD are 100 percent preventable if women abstain from drinking during pregnancy; and

WHEREAS, the **Hawai'i State Department of Health, Family Health Services Division**, in partnership with the Fetal Alcohol Spectrum Disorders Task Force, joins the U.S. Department of Health and Human Services and other committed agencies in working to raise awareness statewide to promote open and honest communication about the effects of FASD and encourage and empower our communities to implement activities to prevent FASD; these activities include hosting an event at the Hawai'i State Capitol on September 6, 2012, that will raise awareness about the debilitating effects of these preventable disorders;

NOW, THEREFORE, I, NEIL ABERCROMBIE, Governor, and I, BRIAN SCHATZ, Lieutenant Governor of the State of Hawai'i, do hereby proclaim September 6, 2012, as


"FETAL ALCOHOL SPECTRUM DISORDERS AWARENESS DAY"
